WE IMPACTED 232 MEN THROUGH TWO RESIDENTIAL RECOVERY PROGRAMS FOR MEN (94 BEDS) TO

THIS PROGRAM HAS A 57-BED CAPACITY AT OUR WINSTON-SALEM CAMPUS. DURING 2021-2022, 195 MEN WERE SERVED THROUGH THE PROGRAM, WITH 48 GRADUATING. OF THOSE, 17 GRADUATES WENT INTO OUR 1-YEAR NEW LIFE CENTER TRANSFORMERS PROGRAM. ADDITIONALLY, 12 MEN WENT ON TO OBTAIN OUTSIDE EMPLOYMENT AND 8 MEN TRANSFERRED FROM OUR PROGRAM TO PERMANENT HOUSING. IN OUR RECOVERY PROGRAMS, THERE WERE 58 MEN WHO MADE PROFESSION OF FAITH IN CHRIST, OR WHO REDEDICATED THEIR LIVES TO HIM. ONE RESIDENT IN THIS PROGRAM ATTENDED COLLEGE.

LIFE SKILLS, CAREER DEVELOPMENT, AND OTHER EDUCATIONAL OPPORTUNITIES ARE ALSO OFFERED IN THIS PROGRAM, INCLUDING CLASSES TOWARDS GED COMPLETION, COMPUTER EDUCATION AND COLLEGE COURSES. THIS PROGRAM HAS A 37-BED CAPACITY AT OUR WINSTON-SALEM CAMPUS. DURING 2021-2022, 37 MEN WERE SERVED THROUGH THIS PROGRAM, WITH 4 GRADUATING. ADDITIONALLY, 3 WENT ON TO OBTAIN OUTSIDE EMPLOYMENT AND 2 TRANSFERRED FROM OUR PROGRAM TO PERMANENT HOUSING.
