AND COMPUTER EDUCATION, WORK THERAPY, INTEGRATED BIBLICAL COUNSELING
AND SPIRITUAL GUIDANCE. THIS PROGRAM HAS A 62-BED CAPACITY AT OUR
WINSTON-SALEM CAMPUS. DURING 2024-2025, 96 MEN WERE SERVED THROUGH THE
